The score sheets must be used in conjunction with the CMS Evaluation and Management Guidelines for 1995 and 1997. Other factors must be considered before arriving at the final code reported to Medicare, including but not limited to, medical necessity and removing from the scoring any documented services reflective of separately reported preventive services and non-relevant documentation.

The big difference in the guidelines is in the criteria for the examination. The 1995 criteria require less to be documented for the exam, but the exam criteria are vague and generally leave much to the opinion of the auditor, easily opening the door for differing opinion between auditor and physician.

Exam Element: 1995 guidelines While most of the guidelines remain the same between the two versions, the exam component is very different. The 1995 guidelines include a one-size-fits-all multi-system exam that recognizes body areas and organ systems.

The first audit of those codes showed such high error rates that CMS (then the Health Care Financing Administration) released the 1995 Documentation Guidelines for Evaluation and Management Services to quantify the information needed for each key component (i.e., history, examination, and medical decision-making). The guidelines provided rules about specifics physicians need to document for coders to assign the different levels of E/M visits.
