Minutes, also known as minutes of meeting (abbreviation MoM), protocols or, informally, notes, are the instant written record of a meeting or hearing. They typically describe the events of the meeting and may include a list of attendees, a statement of the issues considered by the participants, and related responses or decisions for the issues.

Board members are in a position of trust. They are making decisions about money invested by corporate shareholders, and they need to be able to prove they acted wisely, in the best interest of the corporation, and without conflicts of interest. Having board meeting minutes helps the board prove they acted in good faith and avoid personal liability for their actions.

Agency Meetings and Public Notices

The minutes of Council meetings are posted upon approval by the City Council. Special meetings are called for a specific purpose so an agenda may not be prepared for those meetings.
