Such examination shall be performed by a practitioner who is licensed and board certified in the state of New York or any other person authorized to examine or evaluate injury or illness by the board.**

**When a claimant treats with more than one attending physician or practitioner, the independent medical examiner shall provide a copy of the report of the independent medical examination to any attending physician or practitioner who has treated the claimant in the past six**

The IME doctor will likely have all of your relevant medical records, including records of previous injuries to the same part of the body that was affected by the recent workplace injury or illness. The examiner will ask you about all of these things, so take the time to review your medical history.**

**In keeping with their core obligations as medical professionals, physicians who practice as industry-employed physicians or independent medical examiners should: (a) Disclose the nature of the relationship with the employer or third party and that the physician is acting as an agent of the employer or third party before gathering health information from the patient.**

***Six Things to Know for an Independent Medical Exam in Tenn ...***

***An Independent Medical Exam involves a request for the claimant to be examined by a doctor who had not previously seen the claimant. This doctor does not provide treatment and is paid by the party who requested the exam and is usually asked to provide an opinion regarding the exam results in writing or in response to questions asked by a lawyer or judge.***

***Independent Medical Examination Guidelines***

***If an independent medical examination is ordered, the injured party may be required to submit to more than one exam. However, the party seeking to compel an examination is often required to pay for the examination. Sometimes the party attempting to compel the examination may choose the examining physician.***
