### Meals and Entertainment Deduction Rules for 2018 and Beyond

You may deduct meals provided to employees. If the food or beverages you provide to employees qualify as a de minimis benefit (that is, they are small amounts provided occasionally), you aren't held to the 50% limit. You can deduct the full cost. Examples of de minimis food and beverages for employees might be coffee and donuts at a staff meeting or an occasional pizza if employees must work ...

### Food Reimbursement Policy | Travel Services | Nebraska

In cases where the University provides a meal (or reimburses the expense of the meal, as the case may be) to individual(s) who are not travelling on behalf of the University (herein defined broadly as "business meals"), the University will pay or reimburse the business meal under the requirements and procedures under this section.

### Staff Policy Manual - Human Resources - Santa Clara University

Employers in certain businesses and industries that provide employees with meals during the workday can deduct the costs of those meals if they are ordinary and necessary business expenses. As a rule, the IRS limits the business meals deduction to 50% of cost, although it may allow a full deduction

### Employee Meals Policy - USU

It might be \$3,000 in increased costs, that's \$100/day, but it sure is NOT \$3,000 in lost revenues, unless your employees would eat there if you didn't offer staff meals! At 15 meals per day and your estimate of \$100/day (\$3,000/month), that's \$6.67/meal. For an 8 hour shift, that amounts to \$0.83/hour.
