### Hazard and Risk : OSH Answers

Safety nets should be manufactured to recognised standards and may be designed to catch falling personnel or falling materials. They should be erected as close as possible to the work – the further a person may fall, the larger the net needs to be. The use of safety nets is normally limited to high level work such as roof work and steel erection.
