ARTICLE 1874. When a sale of a piece of land or any interest therein is through an agent, the authority of the latter shall be in writing; otherwise, the sale shall be void. (n) ARTICLE 1875. Agency is presumed to be for a compensation, unless there is proof to the contrary. (n) ARTICLE 1876. An agency is either general or special.
